CLARIFICATION no. 3

OF THE TENDER DOCUMENTS FOR THE PROCUREMENT OF CONSTRUCTION WORKS ON I GROUP OF DUAL EDUCATION TRAINING CENTRES

Reference number: SEI/EIB/W/01/23

In the procurement procedure no. **SEI/EIB/W/01/23**, the subject of which is procurement of construction works on I group of Dual Education Training Centres, the Contracting Authority has received the questions of the potential Tenderers:

Question no. 1:

If we are interested in participating in both Lots, is it possible for us to be the lead member of a bidding group (lead partner) for one Lot and a member of a consortium for the other Lot?

Answer:

In the Letter of Invitation, as part of the Tender Documents, and in part 2.2 Tender data, within para. 1.1, it is provided that prospective Tenderers may bid for one or both lots as defined in the Tender Documents (TD). In relation to stated provisions, in part 2.1 Instructions to Tenderers, item 3.7 defines A Tenderer may submit Tender or participate as member of Consortium/Joint Venture only in one Tender for each lot. Submission or participation by a Tenderer in more than one Tender per lot will result in the disqualification of all Tenders in which the party is involved. However, this does not limit the inclusion of the same subcontractor in more than one Tender. Furthermore, in part 2.1 Instructions to Tenderers, item 16.1, it is stipulated that Tenders must be submitted for each Lot separately.

In view of the above mentioned, in case it submits a Tender for both lots, the business entity can participate in the Tender for one lot as a leading member of the consortium/joint venture, and in the Tender for the other lot as a member of the consortium/joint venture, but Tenders must be submitted for each lot separately.

Ouestion no. 2:

As part of the bill of quantities for "Lot 2 - Reconstruction and extension of the Training Centre in Požega", in the AG works section, there is item no. 8 - Construction carpentry. We kindly ask you to supplement the project documentation, i.e., the locksmith's scheme, in order to be able to form an adequate offer.

Answer:

Question no. 3:

Please provide us with clarification regarding condition 4. Equipment Capabilities, and in connection with the required equipment under ord. no. 5:

Compressors (connected vehicle) with an effective working pressure of at least 8 bar with a valid expert report on the periodical inspection and testing of the equipment.

Should evidence required for compressors (connected vehicle) be submitted - Copy of the registered vehicle's traffic license or scanned traffic license of the registered vehicle, with a copy of the valid mandatory vehicle insurance policy or a photocopy of the vehicle registration sticker, due to opinion of the Ministry of Internal Affairs that vehicles and equipment which are transported to the construction site i.e. which are intended exclusively for work on the construction site do not need to be registered?

Answer:

Regarding the evidence of the additional condition of equipment capabilities, in Form 3.5.7 of the Tender Documents, in the part of notes, among other things, it is stipulated that within the Tender, in the attachment of the mentioned form, Tenderers should submit a copy of the registered vehicle's traffic license or scanned traffic license of the registered vehicle, with a copy of the valid mandatory vehicle insurance policy or a photocopy of the vehicle registration sticker regardless of the basis of use (ownership, rent, lease), while for other machines and equipment, resident tenderers should submit copies of valid expert findings/reports on the periodical inspection and testing of the equipment or work in accordance with the RULEBOOK ON THE PROCEDURE OF INSPECTION AND CHECKING OF EQUIPMENT FOR WORK AND EXAMINATION OF WORKING ENVIRONMENT CONDITIONS ("Official Gazette of RS", No. 15/2023; Rulebook applies for resident Tenderers; non-resident Tenders shall provide expert findings/reports on the equipment in accordance with their national legislation).

In accordance with the abovementioned, regarding machines and equipment for which there is no legal obligation to register, Tenderers do not submit a copy of the registered vehicle's traffic license or scanned traffic license of the registered vehicle, with a copy of the valid mandatory vehicle insurance policy or a photocopy of the vehicle registration sticker. In this regard, in order to simplify the examination and evaluation of Tenders, Tenderers can submit the opinions of the competent authorities, which they have at their disposal, and which refer to the exemption from obligation to register the respective equipment specified in the Tender.
